No entry fees will be refunded if a dog and/or handler are dismissed from the competition, regardless of the reason. See summary of NADAC rules for other circumstances under which entry fees will not be refunded.

### MEASURING

### JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

## Brief Summary of Rules:

Please refer to [www.nadac.com](http://www.nadac.com) for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. <http://nadac.com/afirm/dogregfrm.asp> A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: [www.nadac.com](http://www.nadac.com)
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No collars, leads, food, toys, clickers, or other aids or devices shall be permitted on the course. No, food, toys, clickers within 10 feet of the ring. Food or small toys can be in a secure container in pocket during a containerized trial.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

## AGREEMENT

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.

1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.

1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.

1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.

1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), **Agility Club of Evansville** (including its officers, directors, members, and event organizing committee), and Metro Sports Center (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.

If you are not coming to have fun with your dog, then this is not the trial for you. We are here to have fun and make it as great of an experience as we can. These trials are very laid back and take place in a relaxed atmosphere. No aggressive dogs or people are allowed!!

We will kinda run on some type of schedule. If the exhibitors come out and help set jump heights then the trials run quite efficiently. If no one helps, then as main workers get tired, the trial will run late and slow. We appreciate your help and thank you in advance.

Metro Sports Center offers a full concessions stand and **does not** allow food to be brought into the Center; only treats and water for your dog will be permitted.

Swap Runs (if offered): We are offering the option of running an extra round of Chances or Jumpers, but you must give up a jumping round to do so. You can give up a round of either Regular or Jumpers to gain an extra round of Chances, or a round of either Regular or Chances to gain an extra round of Jumpers. You cannot gain an extra round of Regular, and you cannot run more than four rounds of jumping classes. If you wish to do this, you must notify the Trial Secretary BEFORE the first course of the trial is built!

## **NOTICE TO EXHIBITORS**

NEW RULES in EFFECT JANUARY 1, 2019:

- You may ask for the gate to be closed and still earn a Q for your run (if it's clean!)
- You get up to 60 seconds in the ring to train after NQing, if you want.
- If you have titles in other venues, you do not have to start in Novice.

**Please help!** We are a small club and always count on exhibitors to help fill the worker board. If you're good at a job – we need you!! If you're not good at a job – we need you and you get free practice!! If you are brand new to a job – we need you and will train you!!

**We will be using the double run style trial... simply running the same course a second time, back to back and without a second walk**

FOOD/TOYS IN POCKET: Food or a small noiseless toy may be carried into the ring in your pocket provided it is contained in a ziplock bag or small container such as a pill bottle. The container cannot be visible in the ring nor within 10 feet of the ring. You cannot indicate to your dog that you have this item on you i.e. patting your pocket. You are not allowed to remove the container until you are at least 10 feet outside the ring. All food and toys must be contained at the trial and none can be left lying about loose

CLEAN-UP: Is A MUST! Please do not let your dog pee on the building, equipment, trash cans or bags etc. You will be asked to leave the site if you do not clean up after your dog(s) or allow your dogs to pee on inappropriate objects.
